



Consent and Waiver – Student Release to Walk, or Ride a Bike, Home from Avon After School programs

the student I/We are enrolling in Your After School program(s), hereby authorize and give consent to Darien After School, L.L.C., dba Avon After School (“Avon After School”), to release my/our child from Avon After School without parental supervision and hereby consent, acknowledge and allow my/our child to walk, or ride a bike, home from Avon After School without parental or Avon After School supervision.

2. I/We acknowledge and affirm that my child is over the age of _____

3. I/We further acknowledge that walking, or riding a bike, home unsupervised may be dangerous for my/our child.

I/We acknowledge the policy regarding Bike Riders in the Thompson Brook School Policy from the [Student / Parent Handbook\(link\)](#) applies to the Avon After School Program and the Avon After School Program is not responsible for damage to or theft of bikes. The following is an excerpt from the Student/Parent Handbook regarding the Bike Rider policy:

“There are two bike racks located at the front (west) side of the building by the office. Students must have written permission from their parents to ride their bikes to school and an appropriate lock to secure it. The school is not responsible for damage to or theft of bikes. Children under 13 years of age are required to wear a helmet. Students should plan ahead for cases of inclement weather and know the backup plan established by the family.”

I/We, on behalf of ourselves, our family, heirs, personal representative(s), and/or assigns, do hereby expressly and specifically assume any and all risk of injury, illness, death or property damage of any kind resulting from allowing my/our child to walk, or ride a bike, home from Your After School and waive, release, absolve, indemnify, and agree to hold harmless Your After School, its employees, agents, independent contractors, the organizers, sponsors, supervisors, and participants in the Your After School program for any claim arising out of injury to my/our child or damage to any property due to my/our election to allow my/our child to walk home from school without parental or Your After School supervision.

6. I/We affirm that I am/we are the parent(s) or legal guardians of the above-named student and have the requisite authority and right to execute this consent and waiver form without any other person or third party's additional consent or approval.

7. This waiver and consent will remain in effect as long as my/our child is enrolled in the Avon After School program(s) or until I/we notify Avon After School in writing that I/we revoke this authorization.
